## Funding and Eligibility Overview

<p><b><u>Purpose:</u></b></p> <p>Provide early detection, screening and referral services for breast and cervical cancers with special emphasis on women of low income and identified vulnerable populations.</p>	<p><b><u>Purpose:</u></b></p> <p>Assist women <i>and</i> men who are medically indigent in securing diagnostic services necessary to determine a diagnosis of breast or cervical cancer and for patients undergoing treatment for breast or cervical cancer.</p>	<p><b><u>Purpose:</u></b></p> <p>Provide Medicaid benefits to uninsured women and men diagnosed with breast and/or cervical cancer and certain pre-cancerous conditions.</p>
<p><b><u>What is covered:</u></b></p> <p><u>Breast Screening</u></p> <ul style="list-style-type: none"> <li>• Clinical Breast Exam (CBE)</li> <li>• Mammography</li> <li>• Ultrasound</li> <li>• Breast MRI (with prior authorization from program)</li> <li>• Fine Needle Aspiration (FNA)</li> <li>• Surgical consultation</li> <li>• Breast biopsy</li> </ul> <p><u>Cervical Screening</u></p> <ul style="list-style-type: none"> <li>• Pelvic examination</li> <li>• Pap/HPV test</li> <li>• Colposcopy with/without cervical biopsy</li> </ul>	<p><b><u>What is covered:</u></b></p> <ul style="list-style-type: none"> <li>• General Anesthesia for diagnostic breast or cervical procedure</li> <li>• LEEP or Conization with LEEP</li> <li>• Biopsy of excision of cervical lesion</li> <li>• Endocervical curettage</li> <li>• Cryocautery of cervix</li> <li>• Laser surgery of cervix</li> <li>• Conization of cervix with or without repair</li> <li>• Dilation and curettage</li> <li>• Paracervical nerve block</li> <li>• Additional services may be covered with approval from WVBCCSP</li> </ul>	<p><b><u>What is covered:</u></b></p> <p>MTA covers all needed medical services specified as a covered benefit or service by WV Medicaid. Coverage will continue until active treatment is complete.</p>
<p><b><u>Enrollment Eligibility:</u></b></p> <ul style="list-style-type: none"> <li>• WV resident</li> <li>• Female</li> <li>• Income at or below 250% of the Federal Poverty Level (FPL)</li> <li>• Uninsured or underinsured</li> <li>• Cervical 21-64 years of age</li> <li>• Breast 40-64 years of age and under the age of 40 that are high risk or symptomatic</li> </ul>	<p><b><u>Eligibility:</u></b></p> <ul style="list-style-type: none"> <li>• WV resident</li> <li>• Income at or below 200% of FPL</li> <li>• 21-64 years of age</li> <li>• Uninsured or underinsured</li> <li>• WVBCCSP enrollment not required</li> </ul>	<p><b><u>Eligibility:</u></b></p> <ul style="list-style-type: none"> <li>• WV resident</li> <li>• WVBCCSP enrollee</li> <li>• Under the age of 65</li> <li>• Diagnosed with breast or cervical cancer and/or certain precancerous conditions that require medical treatment.</li> <li>• Uninsured or otherwise lacking credible coverage</li> <li>• No income eligibility requirements</li> </ul>

# West Virginia Breast and Cervical Screening Program Eligibility Overview

## **Eligibility:**

- West Virginia Resident
- Female
- Age 40-64 (breast)
- Those under 40 with symptoms or high risk
- Those 65 and over who do not have Medicare part B
- Age 21-64 (cervical)
- Income at or below 250% of the current Federal Poverty Level
- Uninsured or underinsured

## **Screening Services:**

- Patient education on breast and cervical cancer screening and early detection.
- Pelvic Exam age 21-64
- Pap test every 3 years age 21-64
- Co-testing with pap/HPV every 5 years or primary HPV (clinician or self-collection) every 5 years
- Clinical Breast Exam, if indicated or requested age 40-64 or under 40 years of age if symptomatic
- Screening mammogram age 40-64
- Screening mammogram for women 65 and over that do not have Medicare part B
- Screening Breast MRI or Bilateral whole breast ultrasound for high-risk women

## **Diagnostic Services:**

- Diagnostic mammogram (follow up mammogram reimbursed at six-month intervals only)
- Breast ultrasound
- Fine needle aspiration
- Breast surgical consult
- Breast biopsy
- Colposcopy with or without biopsy
- Endocervical curettage
- Loop electrosurgical excision procedure (LEEP) and associated pathology
